CENTRAL INTERSTATE LLRW COMMISSION SPECIAL MEETING THURSDAY, February 25, 2021 at 10:00 A.M.

In compliance with Commission Bylaws and Rules, a meeting notice announcing the date, time, location, and agenda availability was emailed to the interested public on Thursday, February 18, 2021.

A Special Meeting of the Central Interstate Low-Level Radioactive Waste Compact Commission (CILLRWCC) was held Thursday, February 25, 2021 via Zoom to take necessary action on new website, the budget, audit, the upcoming annual meeting, and all other business to come before the Commission.

The meeting was called to order at approximately 10:00 a.m. and roll was called. Responding to the roll call were Kelly Dixon, Oklahoma Commissioner and Vice-Chair; Mike Stickney, Alternate Oklahoma Commissioner; and Scott Blackwell, Louisiana Commissioner. Not present were George Overbey, Arkansas commissioner and Rick Brunetti, Alternate Kansas Commissioner.

The Administrator, Kristie Ann Valtierra; Previous Commissioner, Jon Roberts; and Court Reporter, Christy Myers were also present on the conference call.

No members of the public spoke during the public comment period.

The Chair addressed the first agenda item, the Administrator report. The Administrator requested an upgrade to QuickBooks 2021 since the current version was out of date and continuously crashed. The Administrator also requested a laptop computer for business purposes. Commissioners decided that the funds would be taken from the designated miscellaneous funds in the budget and Scott Blackwell, Chair Commissioner would send the Administrator an email approving the purchase. The Commission also discussed digitizing records and the appointment of a new commissioner for Kansas. The Administrator then gave a budget update. Due to Covid, the Commission is behind on audits for the last two years. This will be rectified before the next meeting.

The Administrator will work with the Low-Level Waste Forum (LLWF) to repair the site. The Commission is now using a new email address due to website changes. The new email is cillrwcc@gmail.com. Kelly Dixon, Oklahoma Chair also discussed record retention. It was decided that the Administrator would gather quotes to present before the Commission at the annual meeting to be voted on.
